

ORDINANCE NO. 2021-11

AN ORDINANCE OF THE TOWNSHIP OF MAPLE SHADE,
IN THE COUNTY OF BURLINGTON, NEW JERSEY,
APPROPRIATING \$966,928.10 IN AMERICAN RESCUE PLAN
FUNDS TO VARIOUS SANITARY SEWER AND WATER
SYSTEM IMPROVEMENTS IN AND FOR THE TOWNSHIP

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF
MAPLE SHADE, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than a
majority of all members thereof affirmatively concurring), AS FOLLOWS:**

Section 1. \$966,928.10 is hereby appropriated from the Utility Capital Fund for capital improvements to the Township's sewer system, including, without limitation, improvements to pump stations and replacement of the Collins Lane sewer main, and capital improvements to the Township's water system, including, without limitation, replacement of water mains (including Indian Queen Avenue) and improvements to the Main Street Water Plant, including replacement of the lime system and upgrades to the supervisory control and data acquisition system and lighting upgrades, and including all work and materials necessary therefor and incidental thereto.

Section 2. The capital budget (or temporary capital budget, as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget (or amended temporary capital budget, as applicable) and capital program as approved by the Director of the Division of Local

Section 3. This ordinance shall take effect in accordance with applicable law.
