### 1. **MAPLE SHADE FIRE DEPARTMENT UPDATE #4**

On Wednesday August 4<sup>th</sup>, Township Council and Members of the Independent Fire Company No. 1 met with the Rodgers Group to go over the Fire Department Report. During the meeting, all in attendance had the opportunity to ask questions regarding the report. Council, after hearing the report, then met separately to discuss the findings as presented and ultimately decided to introduce an ordinance that would restructure the current operations of the Maple Shade Fire Department. The township has no intention of not honoring the long-standing history of the Independent or the men and women that have served the community. Throughout this entire process the Township has stood on that promise in conversations with the Chief, President, and membership. Their service is owed our gratitude. While the township has introduced an ordinance to meet the current fire protection needs of a growing community, it is our hope that the firefighters of the Independent will choose to be a part of the new Township volunteer fire department and continue their tradition of service to the community.

### 3. **3<sup>rd</sup> QUARTER TAX BILLS DELAYED**

The 3<sup>rd</sup> Quarter Tax Bills normally due August 1st are **delayed and will be mailed on August 20, 2021.** The **grace period** to pay without interest will be **extended to September 13, 2021.**

## 6. MAPLE SHADE WATER & SEWER

### HAVE YOU SEEN A RECENT SUDDEN INCREASE IN YOUR WATER BILL?

When residents experience a sudden increase in their water bill, the cause is usually a leaking toilet. A toilet leaking 10-gallons per hour which goes undetected will waste 21,600 gallons of water in a billing quarter. Test kits to detect leaks are easy to use. Simply drop a single dye tablet in the toilet water tank and let it sit for ten minutes. If the dye is observed in the bowl after ten minutes, your toilet is leaking. Replacing the flapper usually resolves the issue. Maple Shade Utilities supplies leak test kits to residents free of charge. Test kits can be obtained at the utility at 432 W. Park Avenue or at the Tax Office at 200 Stiles Avenue during normal business hours. Residents can call the utility at (856) 488-7450 for additional information.



## 7. MAPLE SHADE POLICE DEPARTMENT

### NJ Law on Fireworks

Several years ago, New Jersey approved a change in the law that allowed for de-regulated novelty devices such as sparklers, smoke devices, party poppers, snakes and snappers or drop pops. It also permitted non-aerial sparkling devices such as ground sparkling devices, sparkling wheel devices and ground-based sparklers containing under 500 grams of a pyrotechnic mixture. Although legal in New Jersey, due caution should still be exercised because these items burn at a very high temperature and could easily injure someone especially a child.

What remains illegal in New Jersey are bottle rockets, firecrackers, M-80's or any increasing volume of explosive materials without a permit, reloadable shell devices/roman candles, aerial displays and single tube devices that shoot flaming objects. Below is a graphic that encapsulates what is and what is not illegal. New Jersey Statute Chapter 21 covers the possession and use of illegal fireworks which is a petty disorderly offense punishable by up to 30 days in jail and up to a \$500 fine.

This past 4<sup>th</sup> of July saw some of the highest call volume for our police department regarding illegal firework's complaints. Whether it was the repetitive lighting of explosive based fireworks, debris falling in resident's yards from aerial displays, people concerned over their pets or children being scared by the loud noises, concerns over fire dangers... it all generated calls to our agency which in turn required us to respond out into the community and address these complaints.

As an agency and in an effort to eliminate any confusion on the topic of fireworks, especially with our neighboring state of Pennsylvania, taking a much more lenient position on this topic, we have put this article together so our residents can be educated and made aware before any action needs to be taken by our officers. Please take note moving forward and if you have any questions on fireworks, you can refer to the New Jersey Division of Consumer Affairs at [njconsumeraffairs.gov](http://njconsumeraffairs.gov) and simply type "Fireworks" into the search bar. ## 8. DEPARTMENT OF PUBLIC WORKS

Information to know about **Grass Clippings**....

- When blown into streets, they may clog storm drains and cause water to back up into our roadways.
- These clippings get into our gutters and flow down the stormwater system into our lakes, streams, and rivers.
- Grass clippings that end up in our waterways contribute excess nutrients and pollutants to the water
- These nutrients aid algal growth which can lead to large amounts of algae in the water body.
- The algae consume most of the oxygen in the water; therefore, depriving other aquatic organisms of oxygen which results in death and migration of other aquatic organisms.
- While a few grass clippings mowed into the street look rather innocent, collectively, they have a major impact on our water quality.
- Township Code *Chapter 175-5 Yard Waste*, prohibits sweeping, raking, blowing, or placing yard waste that is not containerized at the curb or along the street and closer than 10-feet from any storm drain inlet.
