WHEREAS, it was agreed that the Township and the Independent would meet with their respective counsel and prepare a Memorandum of Understanding identifying the agreements and obligations of the Independent and the Township; and

WHEREAS, the Township Council agreed to enter into a Memorandum of Understanding upon such terms and conditions reviewed and approved by the Township Manager and Township Attorney; and

WHEREAS, the parties have prepared such Memorandum of Understanding and upon Council review and approval, executed the same.

NOW THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Maple Shade, County of Burlington that the Township Council hereby memorializes its acceptance of the Memorandum of Understanding with the Independent Fire Company No. 1 of Maple Shade.

RESOLUTION REQUESTING AN ADDITIONAL 3-MONTH EXTENSION OF TIME FOR AWARD OF A CONSTRUCTION CONTRACT FOR THE COMBINED FY2019 AND FY2020 MUNICIPAL AID GRANT FUNDED PROJECT.

- **WHEREAS**, the Township of Maple Shade submitted Application MA-2019-Collins Lane- 00013 requesting \$335,340.00 for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue;
- WHEREAS, the New Jersey Department of Transportation (NJDOT) awarded FY2019

 Municipal Aid grant funding in the amount of \$250,000.00 for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue;
- WHEREAS, the Township of Maple Shade submitted Application MA-2020-Municipal Aid Program-00070 requesting \$433,320.00 for additional funding for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue; and for resurfacing of North Coles Avenue from Collins Lane to West Park Avenue;
- WHEREAS, the NJDOT awarded FY2020 Municipal Aid grant funding in the amount of \$231,500.00 as additional funding for resurfacing of Collins Lane from North Coles Avenue to West Roland Avenue; and for resurfacing of North Coles Avenue from Collins Lane to West Park Avenue;
- **WHEREAS**, the Township of Maple Shade intends to combine FY2019 and FY2020 NJDOT Municipal Aid grant funding into one construction project to provide cost effective use of the funds:
- **WHEREAS**, the original deadline for award of a construction contract for the FY2019 Municipal Aid project was March 25, 2021;
- WHEREAS, delays were experienced in the design process as a result of the Township of Maple Shade being in the process of conducting utility work within the project limits; as a result of incidental design modifications requested by the Township of Maple Shade; and as a result of the declaration of a state of emergency by the Governor of New Jersey due to COVID-19 as well as the stay-at-home order which impacted staffing and work production on the roadway design plans;
- **WHEREAS**, the Township of Maple Shade, by Resolution 2021-R-47, requested and was granted a 3-month extension of time deadline for award of a construction contract for the combined FY2019 and FY2020 Municipal Aid project, to June 25, 2021;
- WHEREAS, the Township of Maple Shade was in the process of conducting utility work within the project limits. Sanitary sewer televising had been performed; however, replacement of a sanitary sewer main was still required within the project limits of Collins Lane, between North Coles Avenue on the southeast side of Collins Lane and North Coles Avenue on the northwest side of Collins Lane:

- **WHEREAS**, the original design submission was submitted later than originally anticipated delayed due to the incidental design modifications to the original scope of work;
- WHEREAS, the Township of Maple Shade, by Resolution 2021-R-82, requested and was granted an additional 3-month extension of time deadline for award of a construction contract for the combined FY2019 and FY2020 Municipal Aid project, to September 25, 2021;
- WHEREAS, the Township of Maple Shade is still in the process of conducting replacement of a sanitary sewer main within the project limits of Collins Lane, between North Coles Avenue on the southeast side of Collins Lane and North Coles Avenue on the northwest side of Collins Lane;
- **WHEREAS**, the design submission to NJDOT resulted in numerous issues identified by NJDOT that needed to be addressed prior to bidding and award of the contract;
- **WHEREAS**, the declaration of a state of emergency by the Governor of New Jersey due to COVID-19 has continued to impact staffing and work production on the roadway design plans;
- **WHEREAS**, at the present time the project has been advertised for bids and award is anticipated on September 23, 2021 prior to the current award deadline of September 25, 2021;
- **WHEREAS**, in the event that due to unforeseen circumstances the time for receipt of bid needs to be extended, additional time would be needed for award of a construction contract;
- NOW, THEREFORE BE IT RESOLVED that the Township Council of the Township of Maple Shade, Burlington County, New Jersey, hereby requests an additional three (3) month extension of time to award a construction contract for the combined FY2019 and FY2020 NJDOT Municipal Aid project, or until December 25, 2021.
