

## NOTICE OF PENDING BOND ORDINANCE AND SUMMARY

PUBLIC NOTICE IS HEREBY GIVEN that the bond ordinance, the summary terms of which are included herein, was duly introduced and passed upon first reading at a regular meeting of the Township Council of the Township of Maple Shade, in the County of Burlington, New Jersey, held on June 23, 2022. It will be further considered for final passage and adoption, after public hearing thereon, at a regular meeting of said Township Council to be held in the Municipal Building, 200 Stiles Avenue, Maple Shade, New Jersey on July 21, 2022 at 6:30 o'clock p.m. During the week prior to and up to and including the date of such meeting, copies of the full ordinance will be made available at not cost and during regular business hours, at the Township Clerk's office in the Municipal Building to the members of the general public who shall request the same. The summary of the terms of such bond ordinance follows:

Title: An Ordinance of The Township of Maple Shade, In the County of Burlington, New Jersey, Providing for Various Capital Improvements and Related Expenses in And for The Township, Appropriating \$2,970,000 Therefor, And Authorizing the Issuance Of \$2,604,000 In General Improvement Bonds or Notes of The Township To Finance The Same.

Purpose: 1. Improvements to Township owned property, including but not limited to improvements to the municipal complex and other facility renovations, as set forth in a list on file in the office of the Township Clerk, including all work and related materials necessary thereof or incidental thereto.
