### 10. <u>MUNICIPAL STAFF TO PARTICIPATE IN ACTIVE SHOOTER TRAINING - FRIDAY, SEPTEMBER 30<sup>th</sup>, 2022</u>

#### 12. UTILITIES

The summer has been warm, and the New Jersey weather has been beautiful! But, with that, also comes a rainfall deficit.

Currently, the State of New Jersey is under a drought warning. There are no mandatory restrictions in place, but the Department of Environmental Protection has asked all residents to voluntarily conserve water and reduce outdoor water use. Here is some helpful information from the NJDEP:

#### NEW JERSEY ENTERS DROUGHT WATCH Murphy Administration Urges NJ Residents and Businesses to Conserve Water to Avoid Worsening Water Supply Conditions



New Jersey Commissioner of Environmental Protection Shawn M. LaTourette issued a statewide **drought** watch as of August 9, 2022, and the Murphy Administration is urging residents and businesses to conserve water as persistent dry and hot conditions continue to stress water supplies throughout the state.

The Commissioner's declaration of a drought watch is the first in the State's three-stage drought advisory system. The watch is intended to sow public awareness and appreciation of the stress upon water supply sources and encourage voluntary water conservation measures. If conditions do not improve, declaration of a drought warning or a drought emergency with mandatory water use restrictions may become necessary. Voluntary conservation measures at the watch stage can help to avoid more serious and restrictive drought conditions.

"Stream flow and ground water levels are falling below normal for most of the state and some reservoirs are showing steep rates of decline as hot and dry conditions continue," Commissioner LaTourette said. "While water conservation is always important, it becomes critical during prolonged dry and hot periods like New Jersey has been experiencing. If residents and businesses do all they can to reduce water demand, together we can ensure ample supplies in the coming weeks and months."

At this time of year, more than 30 percent of water demand in suburban areas is for outdoor purposes, much of which can be reduced or avoided. The public can make a big difference by reducing watering of lawns and landscaping, reducing the washing of vehicles, and cutting back nonessential uses such as hosing off driveways and sidewalks. Residents and businesses can also practice many conservation measures to reduce indoor water use. On July 26, the <u>DEP reminded residents and businesses</u> of the impact hot and dry conditions could have on supplies and asked for the public's assistance to moderate demand. Water conservation measures are vital tools that will help New Jersey residents and businesses as we continue to confront a changing climate.

As explained in the New Jersey-specific <u>Scientific Report on Climate Change</u> first released in July 2020, while New Jersey will experience a greater frequency of intense rain events and decreases in precipitation may occur in the summer months, resulting in greater potential for more frequent and prolonged droughts.

The most up-to-date information about the status of New Jersey's water supplies can be found at <a href="dep.nj.gov/drought">dep.nj.gov/drought</a>. The last drought watch or warning to be declared in New Jersey was in 2016. The last drought emergency with mandatory water use restrictions was declared in 2002. In October 2016, the DEP placed14 counties in the northern, central, and northern coastal areas of New Jersey under a drought warning due to ongoing precipitation deficits and deteriorating water-supply conditions, particularly storage levels in reservoirs. At the same time, regions along the lower Delaware River were placed under a watch. All regional drought warnings and watches were lifted by August 2017. In March 2002, then-Governor Jim McGreevey declared a drought emergency, which was lifted in January 2003.

The DEP is continuing to closely monitor drought indicators, which include precipitation, stream flows, reservoir levels, ground water levels, and water demand. DEP will continue to inform the public, local governments, and water systems of future actions to mitigate the risk of more severe conditions.

#### 13. MUNICIPAL PROJECT UPDATES

Residents may have noticed many different projects around town over the past several weeks. Here are just a few of what has been happening:

1. Safe Routes to Schools - Pedestrian Safety Improvement Project

This Federally Funded Project replaced portions of curbs, sidewalks and handicap ramps along

Frederick and S. Clinton Avenues. The project is meant to improve pedestrian safety along a school
corridor. Work began in mid-July and was substantially completed the 3<sup>rd</sup> week of August.

#### 2. Collins Lane & N. Coles - NJDOT Project

The Township, having received NJDOT Funding for this project, will replace portions of curbs, sidewalk, aprons and roadway on both Collins Lane and N. Coles Avenue. Work to these roadways began the week of August  $22^{nd}$  and will continue through the month of September.

#### 3. 2022 Roadway Restoration Project - Milling & Paving

Beginning the week of August 29th, **West Gradwell Avenue** – from Clinton Avenue to South Coles Avenue; **Anna Avenue** – from South Forklanding Road to South Lippincott Avenue; **Cutler Ave**. – from West Center Avenue to the End will undergo a milling and paving project. The work to these roadways will provide much needed improvements and extend the life of the roadways.

#### 4. Resurfacing of South Lippincott Ave - Award of Contract

At the August 18<sup>th</sup> Meeting, Township Council awarded a contract to Black Rock Enterprises, LLC for the resurfacing of South Lippincott Ave. The project is being funded by an NJDOT grant that was awarded in 2021. A Project Timeline has not yet been released; however, we anticipate an early fall start date. Residents affected by the work will be notified by the contractor when work will begin.

#### 14. POLICE DEPARTMENT

The Maple Shade Police Department has been very busy over the last few weeks. On August 2, 2022, the Maple Shade Police Department, in conjunction with the Maple Shade Police Chaplain Association PBA 267, hosted a very, successful National Night Out. National Night Out is a totally *Free of Charge* event that included lots of food, fun, and officers getting dunked for the sake of their new colleague, Sitka the K-9 Officer. Many residents also made contributions to the Maple Shade Food Bank. A special shout out to all the generous local business owners who helped make this event possible. A great time was had by all.

On August 17, 2022, Mr. Softee visited the Maple Shade Police Department for "Custard with a Cop". This was the Police Department's first event of its kind in an effort to connect with the youth in the community. Two hundred and sixty-five, happy customers were served ice cream and popsicles in just one hour! The night was full of laughter, conversation, and brain freeze. Many officers and residents were able to find new friends in one another while enjoying a night out. The event was possible thanks to funding from GCADA, Governor's Council on Alcohol and Drug Abuse.
