**WHEREAS**, the Board of Main Street Maple Shade has requested the use of Gazebo Park and the closure of Wallace Avenue and Margaret Avenue for their event on Friday December 2, 2022 from 6:00pm to 9:00pm; and

**WHEREAS**, the Township Police Department has recommended the closure of Wallace Avenue and Margaret Avenue for this event, in the interest of public safety.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Council of the Township of Maple Shade, in the County of Burlington and State of New Jersey, as follows:

1. Main Street Maple Shade is hereby authorized to hold the Holiday Festival on Friday December 2, 2022 from 6pm to 9pm at the Gazebo on Main Street;
2. Wallace Ave and Margaret Avenue will be closed to vehicular traffic on Friday December 2, 2022 from 4:30pm to 10:00pm; and
3. Approval of this event, including use of the Gazebo and the closure of Wallace and Margaret Avenues is subject to the implementation of parking and other safety restrictions deemed appropriate by the Maple Shade Police Department.
