WHEREAS, the Township's Chief Financial Officer, as required by N.J.A.C. 5:30-1, has certified that there are sufficient funds available for the purpose of awarding a contract to said entity, said certification being attached hereto and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Maple Shade, in the County of Burlington and State of New Jersey, as follows:

A RESOLUTION TO AFFIRM THE TOWNSHIP OF MAPLE SHADE'S CIVIL RIGHTS POLICY WITH RESPECT TO ALL OFFICIALS, APPOINTEES, EMPLOYEES, PROSPECTIVE EMPLOYEES, VOLUNTERS, INDEPENDENT CONTRACTORS, AND MEMBERS OF THE PUBLIC THAT COME INTO CONTACT WITH MUNICIPAL EMPLOYEES, OFFICIALS AND VOLUNTEERS

WHEREAS, it is the policy of the Township of Maple Shade to treat the public, employees, prospective employees, appointees, volunteers and contractors in a manner consistent with all applicable civil rights laws and regulations including, but not limited to the Federal Civil Rights Act of 1964 as subsequently amended, the New Jersey Law against Discrimination, the Americans with Disabilities Act and the Conscientious Employee Protection Act, and

WHEREAS, the governing body of the Township of Maple Shade has determined that certain procedures need to be established to accomplish this policy

NOW, THEREFORE BE IT ADOPTED by the Township Council of the Township of Maple Shade that:

Section 1: No official, employee, appointee or volunteer of the Township of Maple Shade by whatever title known, or any entity that is in any way a part of the Township of Maple Shade shall engage, either directly or indirectly in any act including the failure to act that constitutes discrimination, harassment or a violation of any person's constitutional rights while such official, employee, appointee volunteer, or entity is engaged in or acting on behalf of the Township of Maple Shade's business or using the facilities or property of the Township of Maple Shade.

Section 2: The prohibitions and requirements of this resolution shall extend to any person or entity, including but not limited to any volunteer organization or inter-local organization, whether structured as a governmental entity or a private entity, that receives authorization or support in any way from the Township of Maple Shade to provide services that otherwise could be performed by the Township of Maple Shade.

Section 3: Discrimination, harassment and civil rights shall be defined for purposes of this resolution using the latest definitions contained in the applicable Federal and State laws concerning discrimination, harassment and civil rights.

Section 4: The Township Manager shall establish written procedures for any person to report alleged discrimination, harassment and violations of civil rights prohibited by this resolution. Such procedures shall include alternate ways to report a complaint so that the person making the complaint need not communicate with the alleged violator in the event the alleged violator would be the normal contact for such complaints.

Section 5: No person shall retaliate against any person who reports any alleged discrimination, harassment or violation of civil rights, provided however, that any person who reports alleged violations in bad faith shall be subject to appropriate discipline.

Section 6: The Township Manager shall establish written procedures that require all officials, employees, appointees and volunteers of the Township of Maple Shade as well as all other entities subject to this resolution to periodically complete training concerning their duties, responsibilities and rights pursuant to this resolution.

Section 7: The Township Manager shall establish a system to monitor compliance and shall report at least annually to the governing body the results of the monitoring.

Section 8: At least annually, the Township Manager shall cause a summary of this resolution and the procedures established pursuant to this resolution to be communicated within the Township of Maple Shade. This communication shall include a statement from the governing body expressing its unequivocal commitment to enforce this resolution. This summary shall also be posted on the Township of Maple Shade's web site.

Section 9: This resolution shall take effect immediately.

Section 10: A copy of this resolution shall be published in the official newspaper of the Township of Maple Shade in order for the public to be made aware of this policy and the Township of Maple Shade's commitment to the implementation and enforcement of this policy.

TOWNSHIP OF MAPLE SHADE RESOLUTION <u>2023-R-40</u>

RESOLUTION FOR POLICE OFF-DUTY EMPLOYMENT

WHEREAS, the Township of Maple Shade has determined that a policy is needed to manage temporary off-duty police work by establishing requirements for private employers, as defined herein, to follow when the services of off-duty police are required; and

WHEREAS, management of off-duty police work requires established payment schedules, timetables for making requests, hourly rates for off-duty police officers, Workers' Compensation coverage, liability insurance coverage, and fees for the use of municipal vehicles; and

WHEREAS, the Township Police Department administers all aspects of the Township Police Department's off-duty program related to scheduling and the Township Finance Office handles all escrow, billing and collections.

BE IT RESOLVED, by the Mayor and Council of the Township of Maple Shade that any private employer must adhere to the requirements established in the following provisions:

- For purposes of this Resolution, the term private employer shall mean any entity, public or private, other than the Township of Maple Shade that is hiring a police officer of the Township of Maple Shade to provide security, traffic control, or other police-related services for the private employer's business, project, or function.
- 2. Township police officers may work for a private employer on their off-duty hours with the approval of the Chief of Police or his/her designee and provided that the Chief determines, in his/her sole discretion, that there are sufficient police personnel available for such work, that the off-duty work will not interfere with the needs of the Township.
- 3. Any private employer requesting the services of a Township police officer for off-duty police related services shall contact the Maple Shade Police Department no less than 48hours prior to the start of work to schedule officers. Exceptions to the 48-hour requirement will be for those contracts that require work directly affecting the life, safety and welfare of township residents.
- 4. Private employers will be billed a minimum of four (4) hours when work is cancelled with less than two hours' notice.
- 5. The Township hereby establishes an escrow account dedicated to the payment of Township police officers for off-duty police related services at the rate set forth herein. The Chief Financial

Officer shall ensure exact funds for the payment of off-duty employees are deposited in the escrow account prior to the start of any off-duty work.

- 6. If, at any time, the deposit in the escrow account is less than the amount of funds that are needed to pay for off-duty police related services, the Chief Financial Officer, Chief of Police or his/her designee shall notify the contractor of same and ensure the account is replenished. No additional work may be performed until escrow is replenished.
- 7. The hourly rate to be billed to the contractor for off-duty police related activity shall be \$120.00 per hour for the year 2023. This rate shall cover the off-duty police officer's hourly rate, all applicable taxes, the cost for the use of the police vehicle, plus a reasonable sum representing the administrative costs and any overhead or out-of-pocket expenses the Township of Maple Shade may incur for providing this service.
- 8. The private employer shall provide proof of Workers' Compensation coverage in the event an off-duty police officer is injured while working an approved off-duty assignment.
- 9. The Private Employe shall be required to submit a signed Indemnification and Hold Harmless Agreement and Certificate of Insurance from an insurance company authorized to do business in New Jersey. The Workers' Compensation and Employers' Liability coverage shall be in accordance with the laws of the State of New Jersey. The Commercial General Liability insurance coverage policy limits must be not less than \$1,000,000.00 per occurrence and \$2,000,000.00 general aggregate for bodily injury and property damage, including premises/operations and broad form contractual liability. Said Certificate shall name the Township of Maple Shade as an additional insured for all coverages except Workers' Compensation.

BE IT FURTHER RESOLVED, that all Township employees and officials are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
