- ✓ Remain in your car.
- ✓ Put paper in your trunk or truck bed; our staff will remove it from your vehicle.
- ✓ **Confidential files ONLY - ABSOLUTELY NO MAGAZINES/JUNK MAIL!**
- ✓ Limit of 4 bags/boxes of unshredded paper weighing no more than 10 lbs. each. Shredded paper is also accepted.
- ✓ No businesses or non-profits.

SPECIAL PLASTIC COLLECTION AT SHRED EVENTS

You may bag up separately and bring plastic bubble wrap, air pillows, plastic shipping mailers, and plastic wrap from cases of water or paper products.

BURLINGTON COUNTY RESIDENTS ONLY.

County Groups GO GREEN and Take the Trex Recycling Challenge



Plastic bags and film such as shipping mailers, bubble wrap, case wrap, and bread bags cannot be put in curbside recycling because recycling systems can't sort them. But, if collected separately by volunteer groups, these plastics are perfect for the Trex company to make into high quality decking and furniture.

Last fall, the Board of Commissioners partnered with Trex to provide a regional delivery point at the County Recycling Center for volunteer groups to bring the bags and film they collect.

"We've had a great response from amazing volunteer groups who have taken the Trex Challenge," said Commissioner Deputy Director Tom Pullion. "Groups like the Medford Green Team and the Mt. Holly Women's Club have collected several hundred pounds in only a few months. Girl Scout Troop 27140 has also

collected over 500 lbs. and is working to donate Trex benches to area schools. I would like to congratulate these groups for their efforts to keep plastic out of our landfill."

The Trex challenge is open to community groups, civic clubs, religious organizations, youth groups, athletic leagues and more.

Are you ready to take the challenge and earn a bench from Trex?

- Learn more and register at NexTrex.com
- Select a 6 month period to collect a minimum of 500 lbs. of plastic film and bags.
- Trex provides posters and recycling bins.
- Weigh and report what you collect each month to Trex.
- Deliver your plastic to the County Recycling Center or participating retailer (Acme, Kohls, Wegmans).

Businesses Can Recycle Too!

Does your business generate shrink wrap, bubble wrap, case wrap, dry cleaner bags, furniture or mattress wrap, etc? Keep it out of the landfill and deliver it to the County's recycling center by appointment.

Paper and Cardboard

EMPTY, FLATTEN AND FOLD



Plastic Bottles and Food Containers



Empty and rinse containers.
No loose caps.



Glass Bottles and Jars

Labels are okay!
No caps or lids.



Metal CANS Only

Remove labels on aluminum cans.

Don't crush!



Cartons

Rinse and recap.



SET RECYCLING OUT BY 6 AM

Metal bar must face the street.

DO NOT RECYCLE:

NO STYROFOAM

NO shredded paper

NO plastic with a



NO plastic bags, wrap, plastic envelopes, or shipping packaging

NO plant pots, straws, trays, lids, cups, loose caps, or coffee pods

NO hoses or hangers

NO hardback books, food soiled, or frozen food boxes

NO foil items, bulbs, cookware, or window glass

NO motor oil, batteries, or hazardous items

NEVER put syringes in recycling!
