PUBLIC PORTION – Andrew Simonsick, 17 Overbrook Avenue, questioned the hiring of a Director of Fire Safety, then continued with the following statement: "I'm gonna make a statement here and yous all need to think about it. The attorney included because I can't believe you're allowing them to draft things like this knowing title 40 and knowing how this township is set up. However, with her discision to talk you five into shutting down the fire department and all the chaos that has ensued over that point in time our grid is still not in place because the state's involved in it and the state, in their infamous wisdom, has taken upon themselves to lessen the grids that were initially put on there by us to Fox Meadow and me, as the Chief and as a professional, right now, I will say to all of you, six/seven are accountable in some shape or form for the death of those two children whether you think so or not because our initial response had been taken down because the state got involved in it and it was all due to her (Manager) bringing the state in here, her making the decision and yous deciding to shut the fire department.

So yous need to think about that before you go doing it. I sat in this room and extended an olive branch to every five of you about coming up here and trying to straighten all this out, and you know what I got from you? Absolutely Nothing, nothing. She came into town, there wasn't one problem in this town until she showed up. She's driven a wedge between us, you can sit there and laugh all you want, Nelson. Nelson: Thank you. Mr. Simonsick: We're gonna show you what leadership's all about by the people of this town. If you think Joe Dugan and Joe Andl are gonna help you with your elections this time around, you're sadly mistaken. Yous all need to think about what you're doing, what you're costing this town. That woman doesn't even live in this town. She makes decisions, goes home and could care less about this town cause she doesn't live here, it doesn't directly affect her. But yous do live here and her decisions are affecting you and if you're buying into everything without going and talking to the experts, the people like us that've been around this whole time then I feel sorry for yous, because I guarantee you won't be doing this to the Police Department without going and talking to them. And I resent the fact that you got Bill Cramer in this building making decisions and working with him behind my back. I'm not asking you to speak! Manager Danson: Andrew, you will not sit there and vell at me.

Mr. Simonsick: You have been going behind my back since the beginning. You say everything you want to say, it's propaganda and you haven't put your money where your mouth is. And I'm also telling yous right now, we were denied to buy a fit test machine for our safety, the number one priority that the state wants us to have and it's law. I'm telling you in public, I'm buying it. I'm purchasing it and I don't care what you say. Manager Danson: You were not denied, I asked if you had anyone trained to work it and was told by your deputy chief, no. Mr. Simonsick: We don't need anyone trained, it's a self-contained unit and if we buy it, I'm sure we will have it trained. You want to make excuses and say things that have nothing to do with it. No, I'm not talking to you, Yous need to think about what I said. You're a disgrace to this township."
