## TOWNSHIP OF MAPLE SHADE Ordinance 2023-21

AN ORDINANCE AMENDING MAPLE SHADE TOWNSHIP CODE CHAPTER 114, ARTICLE III "MOTELS AND TEMPORARY HOUSING ACCOMODATIONS"

**NOW THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Maple Shade as follows:

**Section 1**. Maple Shade Township Code § 114-29 "Violations and penalties" is replaced with the following:

- § 114-29 Violations and penalties
  - A. Any person, firm, partnership, corporation or entity violating any provision of this article by the performance of a prohibited act or by failing, neglecting or refusing to do any act or anything required by this article, other than the parking violation provided in § 114-17A(2)(d), upon conviction, shall be subject to a fine of not more than \$2,000, imprisonment for a term not exceeding 90, a period of community service not exceeding 90 days or any combination thereof in the discretion of the Municipal Court Judge.
  - B. Any guest violating § 114-17 A(4)(a) regarding the maximum period of occupancy shall be subject to fine of:
    - 1) \$100 for the first offense;
    - 2) \$500 for the second offense;
    - 3) \$1000 for any subsequent offense.
  - C. Each day on which a violation exists shall be considered a separate and distinct violation and subject to the imposition of a separate penalty for each day of the violation, as the Municipal Court Judge may determine.

All other provisions of Chapter 114, Article III shall remain as written.

**Section 2.** This Ordinance shall take effect upon final passage and publication according to law.

**Section 3.** All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

**Section 4.** If any section, paragraph, subdivision, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.
