AUTHORIZING THE OPT-IN EXAMINATION EXEMPTION TO CIVIL SERVICE HIRING PROCEDURES

WHEREAS, the Township of Maple Shade, New Jersey is a jurisdiction governed by Title 11A and the Civil Service regulations and rules established under Title 4A of the Administrative Code; and

WHEREAS, in 2022 the State of New Jersey legislature enacted P.L.2021, C7 (the "Act") permitting municipalities to hire police officers who may not have taken an open competitive examination for the title of Police Officer, but are otherwise duly qualified, provided they have completed training and hold a valid NJ Police Training Commission Certificate as Police Officer (Basic Course for Police Officer); and

WHEREAS, the Act permits a municipality to exempt any person or an entry-level law enforcement person from taking the Civil Service law enforcement exam, as long as they have completed the full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police Training Commission; and

WHEREAS, on February 4, 2021, the New Jersey Legislature adopted P.L.201 C.7 and amended it on July 18, 2022 which allows a municipality to "exempt from the requirement to take an examination for entry-level law enforcement position a person who has successfully completed a full Basic Course for Police Officers training course at a school approved and authorized by the New Jersey Police training Commission within nine months from the date of hire as a temporary entry-level officer."; and

WHEREAS, the Act would also require that a municipal or county police department may hire a person under this exemption only upon adoption of a conflict of interest and nepotism policy, and which is already in place; and

WHEREAS, the Township has duly established written policies governing nepotism and conflicts of interest; and

WHEREAS, in order to effectuate this policy, a municipality must affirmatively "opt-in" by adopting a resolution authorizing such a hiring policy; and

WHEREAS, The Chief of Police and Township Manager have recommended that the Township effectuate this policy and "opt-in" to this program in the interests of efficiency, expediency, and promotion for public safety within the Township; and

WHEREAS, this "opt-in" resolution will be renewed annually.

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Maple Shade, County of Burlington, State of New Jersey, hereby authorizes such hiring policies related to the examination exemption as set forth in the Act.

TOWNSHIP OF MAPLE SHADE RESOLUTION <u>2024-R-43</u>

RESOLUTION FOR POLICE OFF-DUTY EMPLOYMENT RATE

WHEREAS, the Township of Maple Shade has determined that a policy is needed to manage temporary off-duty police work by establishing requirements for private employers, as defined herein, to follow when the services of off-duty police are required; and

WHEREAS, management of off-duty police work requires established payment schedules, timetables for making requests, hourly rates for off-duty police officers, Workers' Compensation coverage, liability insurance coverage, and fees for the use of municipal vehicles; and

WHEREAS, the Township Police Department administers all aspects of the Township Police Department's off-duty program related to scheduling and the Township Finance Office handles all escrow, billing and collections.

BE IT RESOLVED, by the Mayor and Council of the Township of Maple Shade that any private contractor must adhere to the requirements established in the following provisions:

- 1. For purposes of this Resolution, the term private contractor shall mean any entity, public or private, other than the Township of Maple Shade that is hiring a police officer of the Township of Maple Shade to provide security, traffic control, or other police-related services for the private contractor's business, project, or function.
- 2. Township police officers may work for a private contractor on their off-duty hours with the approval of the Chief of Police or his/her designee and provided that the Chief determines, in his/her sole discretion, that there are sufficient police personnel available for such work, that the off-duty work will not interfere with the needs of the Township.
- 3. Any private contractor requesting the services of a Township police officer for off-duty police related services shall contact the Maple Shade Police Department no less than 48hours prior to the start of work to schedule officers. Exceptions to the 48-hour requirement will be for those contracts that require work directly affecting the life, safety and welfare of township residents.
- 4. Private employers will be billed a minimum of four (4) hours when work is cancelled with less than two hours' notice.
- 5. The Township hereby establishes an escrow account dedicated to the payment of Township police officers for off-duty police related services at the rate set forth herein. The Chief Financial Officer shall ensure exact funds from the payments of off-duty employers are deposited into the escrow account prior to the start of any off-duty work.

- 6. If, at any time, the deposit in the escrow account is less than the amount of funds that are needed to pay for off-duty police related services, the Chief Financial Officer, Chief of Police or his/her designee shall notify the contractor of same and ensure the account is replenished. No additional work may be performed until escrow is replenished.
- 7. The hourly rate to be billed to the contractor for off-duty police related activity shall be \$123.00 / per hour for the year 2024. This rate shall cover the off-duty police officer's hourly rate, all applicable taxes, the cost for the use of the police vehicle, plus a reasonable sum representing the administrative costs and any overhead or out-of-pocket expenses the Township of Maple Shade may incur for providing this service.
- 8. The private contractor shall provide proof of Workers' Compensation coverage in the event an offduty police officer is injured while working an approved off-duty assignment.
- 9. The private contractor shall be required to submit a signed Indemnification and Hold Harmless Agreement and Certificate of Insurance from an insurance company authorized to do business in New Jersey. The Workers' Compensation and Employers' Liability coverage shall be in accordance with the laws of the State of New Jersey. The Commercial General Liability insurance coverage policy limits must be not less than \$1,000,000.00 per occurrence and \$2,000,000.00 general aggregate for bodily injury and property damage, including premises/operations and broad form contractual liability. Said Certificate shall name the Township of Maple Shade as an additional insured for all coverages except Workers' Compensation.

BE IT FURTHER RESOLVED, that all Township employees and officials are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.

BE IT RESOLVED, by the Mayor and Council of the Township of Maple Shade that the following requirements are established with the following provisions:

- 1. Effective February 1, 2024 when an officer works a Township sponsored event, such as but not limited to, 4th of July Parade, Fireworks, Touch a Truck etc. or a school district security detail at a sporting event, graduation or other similar event, the officer(s) scheduled to work the event will be paid their standard overtime rate. These events are not to be paid at the Police Outside Services Rate; and
- 2. The Maple Shade School District, by way of agreement has agreed that any security detail at a sporting event, graduation or other similar event, will be paid to the officer(s) at a minimum of 3 hours in length. This agreement does not change the previously agreed upon language involving the School Resource Officer with respect to the School District and their agreed upon events that the School Resource Officer shall work. Those events as dictated in the PBA Local 267 Contract shall be paid in accordance with Article 19(B).

BE IT FURTHER RESOLVED, that all Township employees and officials are hereby authorized and directed to take all action necessary and appropriate to effectuate the terms of this Resolution.
