AN ORDINANCE AMENDING CHAPTER 194 OF THE TOWNSHIP CODE ENTITLED "VEHICLES AND TRAFFIC" AT SUBCHAPTER 194-23 TO IDENTIFY A NEW TURN PROHIBITION

BE IT ORDAINED, by the Township Council of the Township of Maple Shade that the Township Code be amended as follows:

Section 1. Chapter 194. Vehicles and Traffic at § 194-23. Turn prohibitions.

ADD the following to the list of prohibited turns in the appropriate alpha-numeric order:

| Intersection 2801 Route 73 South and Waverly Road, Wawa Convenience Store | <u>Turn Prohibition</u> Left | Movement Prohibition From Waverly Ave side driveway of Block 193, Lot 1.02 (Wawa Convenience Store) onto Waverly Road |

Section 2. This Ordinance shall take effect upon final passage and publication according to law.

Section 3. All Ordinances or parts of Ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. If any section, paragraph, subdivision, clause, or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.
