WHEREAS, the Township endorses the local leaders' efforts but also urges Mayor Parker and the City of Philadelphia to go one step further and implement measures to hold the property owners of the parcels used for the boom parties" responsible for these events.

NOW THEREFORE, BE IT RESOLVED by the Township Council of the Township of Maple Shade, Burlington County as follows:

- 1. The Township urges Mayor Parker and the City of Philadelphia to supplement their efforts to stop boom car parties and to consider penalizing not only the event organizers but the hosting property owners who do not act to prevent the parties occurring on their premises.
- 2. The Township appeals to its neighboring communities to reach out to Mayor Parker and the City of Philadelphia letting them know the impact of the boom parties on their residents and the need to expand enforcement.
