PUBLIC PORTION -

Andrew Simonsick, Jr., 17 Overbrook Avenue, asked the Council to expedite the hiring process for his command staff at the fire department. Discussion included the timeframe for the process, Manager Danson explained that she would meet with the chief's recommendation of Deputy Chief next week and submit the resolution to council at the next council meeting, the process was different for Andrew because he was appointed by Judge Fickery not the municipality, and how our form of government works. Councilman Simonsick questioned why he was not copied on the emails and made a public statement, "my son was made the chief of the fire department without my being involved in that now that he is the chief of the fire department, as a councilmember, I have the right to participate in all that so if anyone in front of me right now wants to say that I – there's a conflict of interest there's gonna be a problem, I'm stating right now, in public, and it's being recorded, there is absolutely none, no conflict of interest for any of this, and all the games and charades are gonna start ending tonight, I'm tired of it. You serve at the pleasure of council and everyone in this building does."

Mike Stevens, 47 Cherry Avenue, agreed with the choice of deputy chief.

Debra Simonsick, 17 Overbrook Avenue, questioned the manager, "What makes you proficient in deciding about this fire department? What are your skills?" Manager Danson explained the process and that she is proficient in finding good leaders, it's her responsibility as the manager, and it's her name on the appointment.

STAFF AND PROFESSIONAL COMMENTS – Council wished everyone a Happy Mother's Day and announced two events tomorrow night: Soccer's annual basket auction

and Girl's softball's event at the Alden. Mr. Simonsick made the following statement to the public, "well I've been quiet up until now, I haven't really made statements when it comes to professional and staff comments, um, but, in my opinion, nothing has gotten done in this township since we got here, now maybe other people feel differently, I don't know. However, I don't, um, I look at the um, the things that we ran on as a group of people, um, and I just want the people of this township to know that moving forward I'm going to bring them things up. I'm not going to be sittin around anymore and taking the abuse that I've been taking from this building, so I just want the people of the township to know that I'm one vote, that I'm going to do my best, I'm not going anywhere and I'm gonna deliver on my word with the things that I said that I was gonna do for them. Now whether that happens or not, I don't know, because I am only one vote, but I'm just letting everybody know."

OLD BUSINESS

- 1. Operations
 - a. The Broadway sewer main project was completed on Monday, but due to found issues there will be a follow up project that will include piping and a manhole
 - b. Fireworks will be on June 28th at the High School with the parade starting at noon
 - c. The township hosted 20 students today for "Student in Government", it was a great event. Thank you to Jen Nixon for organizing the event, well done.
 - d. Manager Danson read a statement to counter concerns that have been raised regarding the preparation of our ordinances and resolutions and the role that the township clerk and township manager play in the process.
- 2. Police Report the chief reported and few recent incidents and thanked the officers involved. He also reported on the events at the football carnival which spread to the Forklanding Road Wawa and asked council to consider an ordinance that addressed the use of backpacks and face coverings at public events. Lastly, the "Bring your kid to Work" went well this year and the kids really enjoy the events.
- Site Plan Seven applications including a concept for Park Crossing, front porch on Windsor Avenue, garage on West Woodlawn Avenue and Hot dog business at Dr. Brewlittle's.
- 4. MS Green Team/Sustainable Report meeting next Tuesday
- Additional Mr. Simonsick Any word from the Appraiser for the nursing home? No Mr. Zahradnick – Is the grass supposed to being cut at the nursing home? yes

NEW BUSINESS

- 1. Water/Sewer Fees Manager Danson, brought to council details for the previously discussed possible non-profit property water and sewer fees, including schools. If they were charged the minimum, it would cost them \$16,600 a quarter. Council will consider the program, Mr. Simonsick feels it's moving money around, Mr. Zahradnick feels it would show accountability.
- 2. Fire Department command staff discussion continued, the interview process will take place this week, the job will be posted as per civil service regulations, and the position will be filled by resolution at the next council meeting.

3. Mr. Simonsick -

-At the next meeting he will have a statement of the fire department and history of things to protect this township.

-At the next meeting he will be making a motion to change the ordinance that if you're going to be a township manager you have to reside in the town

-At the next meeting he will be making a motion to change the ordinance that Township Council will appoint the township clerk because, "to me there's a conflict of loyalty, when you get right down to it."

-He is bringing back the Recreation Board because, "we have a recreational director and God knows what she even does, I think we need to get her in here and and have her tell us what she's done for the year so far. She doesn't, apparently, work with the sports organizations, um, and I just feel if we're gonna be paying this money for something like that that she needs to get involved and we need to get our moneys worth out of her position."

-Questioned the three 2025 ordinances, two of which were introduced prior to Ms. McDowell's appointment and the duties of the attorney under our form of government. -Clarified emails

-Questioned a 2023 Merchantville Overhead bill that was not forwarded to the township until 2024 with seven past due notices. And a NAPA bill. Mr. Simonsick gave Manager Danson two ways to pay the bills, "there's two simple solutions to this, it's done all the time, you can call Merchantville overhead, and you say, "can you rebill that with this current date and then the dates done. Or you can just pay the bill with a note on it so if the state comes down here or whoever wants to look at it it's a legitimate bill." Manager Danson requested authorization from the council to pay.

-" Lastly, for you to imply that I need to apologize to you when I'm doing my job and basically threaten me in an email saying that you're going to call the state on me, um, it's just, it it, to me that's ridiculous. My job is to make sure you do your job and again if you don't like that there's the door. Nah, at the end of the day, Susan, I'm done playing games, everybody might think that, you know, this is all peaches and cream up here, but I know different. I was put here by the people of this town and I'm start going what I said I was gonna do at the end of the day the council is responsible for running this town, to give you the marching orders of what we would like to have done, that's how it works, and all the things that you're saying in here, it's the other way around, basically, you threatened me, that's the way I see it, and I'm not apologizing for doing my job, at the end of the day, I think you need to apologize to the people of this town for the things that you keep doing and the games you keep playing, that's my opinion and I'm entitled to it. So, I'm airing this out, I'm not going to take this abuse anymore, I'm not going to take emails like this, I'm not gonna hear that I can't have something - you said at the last meeting I can't see the reports from the building – everything in this town is public. I can come up here and get inspection reports from somebody that built a house thirty years ago. It's all public knowledge and for you to tell that I can't see something is like the president being elected and him being told he can't look at something. I'm done playing games, everybody's been put on notice."
