A RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF MAPLE SHADE SUPPORTING NEW JERSEY SENATE BILL S-1228 AND ASSEMBLY BILL A-4676 CONCERNING EMERGENCY SEIZURE RESPONSE POLICIES IN PUBLIC SCHOOLS

WHEREAS, epilepsy and seizure disorders affect thousands of children throughout the State of New Jersey and the United States; and

WHEREAS, timely emergency response and proper administration of seizure rescue medications can significantly reduce the risk of serious medical complications, injury, and death associated with prolonged seizure activity; and

WHEREAS, Senate Bill S-1228 and its companion legislation, Assembly Bill A-4676, would require public schools in New Jersey to develop and implement policies for the emergency administration of nasal seizure rescue medications and the use of manual vagus nerve stimulators for students with seizure disorders; and

WHEREAS, the Township Council recognizes the importance of ensuring that school personnel are appropriately prepared and equipped to respond quickly and effectively to medical emergencies involving students experiencing seizures; and

WHEREAS, the adoption of standardized emergency response procedures in schools would help provide safer learning environments for students diagnosed with epilepsy and other seizure-related conditions; and

WHEREAS, the Township Council believes that supporting measures which enhance student health, safety, and emergency preparedness is in the best interests of the residents of Maple Shade Township and communities throughout New Jersey; and

WHEREAS, the Township Council further recognizes the efforts of legislators, educators, healthcare professionals, advocates, and families working to improve seizure awareness and emergency preparedness within New Jersey schools.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Maple Shade, County of Burlington, State of New Jersey, that the Township hereby expresses its support for Senate Bill S-1228 and Assembly Bill A-4676 and respectfully urges the New Jersey Legislature and Governor to take all appropriate action necessary to enact this important legislation.
