

# **TOWNSHIP OF MAPLE SHADE**

## **ORDINANCE NO. 2026-14**

### **AN ORDINANCE OF THE TOWNSHIP OF MAPLE SHADE, COUNTY OF BURLINGTON, STATE OF NEW JERSEY, AMENDING CHAPTER 194 OF THE CODE OF THE TOWNSHIP OF MAPLE SHADE, ENTITLED "VEHICLES AND TRAFFIC," TO ESTABLISH ADDITIONAL PARKING RESTRICTIONS AND TRAFFIC REGULATIONS**

**WHEREAS**, the Township Council has determined that certain parking restrictions and traffic regulations are necessary to improve public safety, traffic circulation, emergency vehicle access, and visibility at various locations throughout the Township; and

**WHEREAS**, the Maple Shade Police Department and Department of Public Works have reviewed the locations described herein and recommended the adoption of additional parking restrictions and traffic control measures;

**NOW, THEREFORE, BE IT ORDAINED** by the Township Council of the Township of Maple Shade, County of Burlington, State of New Jersey, as follows:

#### **SECTION I.**

Chapter 194, Article II, §194-10, Parking Prohibited at All Times on Certain Streets, is hereby amended to add the following parking restrictions:

| <b>Street</b>          | <b>Side</b> | <b>Location</b>                                                                                                                                |
|------------------------|-------------|------------------------------------------------------------------------------------------------------------------------------------------------|
| Willow Road            | Both        | From Collins Road North extending approximately 300 feet beyond the entrance/exit serving White Glove Car Wash and Jay's Elbow Room.           |
| North Forklanding Road | East        | Beginning at the southerly curblineline of High Street and extending 100 feet southerly therefrom.                                             |
| East Mill Road         | North       | Beginning at the easterly curblineline of Spruce Avenue and extending 50 feet easterly therefrom.                                              |
| East Mill Road         | North       | Beginning at the westerly curblineline of Spruce Avenue and extending 50 feet westerly therefrom.                                              |
| West Linwood Avenue    | North       | Beginning at the entrance gate to the Township hockey rink and extending to a point 300 feet east thereof.                                     |
| West Linwood Avenue    | South       | Beginning at the entrance gate to the Township hockey rink and extending to a point 100 feet east thereof adjacent to Township-owned property. |

#### **SECTION II.**

Chapter 194, Article II, §194-10, Parking Prohibited at All Times on Certain Streets, is hereby further amended by revising the existing parking restrictions for Clinton Avenue, South, to read as follows:

|----------------------------------------|-------------|--------------------------------------------------------------------------------------------------------------------------------------------------|
| Clinton Avenue, South                  | East        | From the southerly curblin of Main Street to the northerly curblin of Anna Avenue.                                                               |
| Clinton Avenue, South                  | West        | Beginning at the point of curvature at the intersection of Anna Avenue and Clinton Avenue and extending 15 feet west along the northern curblin. |
| High Street and North Forklanding Road | South       | From the southerly curblin of High Street, adjacent to the stop sign approximately 60 feet from the intersection with N. Forklanding Road        |

The foregoing provisions shall replace the existing entries for Clinton Avenue, South, contained in §194-10.

### **SECTION III.**

Chapter 194, Article IV, §194-23, Turning Prohibitions, is hereby further amended to add the following prohibitions:

| South Forklanding, west side<br>South of Mill Road | Right                   | From South Forklanding to Maude Wilkins Elementary School |

### **SECTION IV**

Chapter 194, Article IV, Traffic Regulations, is hereby amended by adding a new section entitled §194-24.1 – Local Traffic Restrictions, to read as follows:

#### **§194-24.1 Local Traffic Restrictions.**

The following roadway is hereby designated as a Local Traffic Only roadway:

| Buena Vista Avenue | No thru traffic. Local residents and deliveries only. |

The Department of Public Works is authorized to install and maintain the appropriate regulatory signage at each entrance to Buena Vista Avenue advising motorists:

**NO THRU TRAFFIC**  
**LOCAL RESIDENTS / DELIVERIES ONLY**

### **SECTION V.**

The Department of Public Works, Chief of Police, and other appropriate Township officials are hereby authorized and directed to install and maintain all traffic control devices and signs necessary to implement the provisions of this Ordinance in accordance with the Manual on Uniform Traffic Control Devices (MUTCD) and applicable provisions of New Jersey law.

### **SECTION VI.**

All ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency.

### **SECTION VII.**

If any section, subsection, sentence, clause, or phrase of this Ordinance is held to be invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

### **SECTION VIII.**

This Ordinance shall take effect upon final passage, approval, publication according to law, and the installation of the appropriate traffic control devices.

### **NOTICE OF INTRODUCTION**

The foregoing ordinance was introduced at a meeting of the Maple Shade Township Council, held on August 6, 2026, and was read for the first time.

This ordinance will be further considered for final passage at a Regular Meeting of the Township Council to be held on September 10, 2026, at 6:30 P.M. at 200 Stiles Avenue, Maple Shade, NJ 08052.
