WHEREAS, the Burlington County Bridge Commission, pursuant to its authority under N.J.S.A. 27:19-31 et seq., is authorized to issue bonds and other obligations and to enter into agreements with governmental entities for the acquisition, construction, financing, leasing, and improvement of public facilities; and

WHEREAS, the Township and the Burlington County Bridge Commission desire to explore entering into an appropriate form of financing agreement, setting forth the respective responsibilities of each party with respect to the financing of the costs of the subject public improvements; and

WHEREAS, the Township Council finds that it is in the best interests of the Township to authorize its administrative officials to negotiate the terms and conditions of such an agreement, and to take all actions necessary to obtain financing for the costs of the proposed public improvements; and

WHEREAS, the Township Council desires to authorize the Township Manager, Chief Financial Officer, and Township Solicitor to work collaboratively with the Burlington County Bridge Commission and all necessary professionals to prepare the required agreements, financing documents, and related materials for Council consideration and approval.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Maple Shade, County of Burlington, State of New Jersey, as follows:

1. The Township Manager, Chief Financial Officer, and Township Solicitor are hereby authorized and directed to negotiate the terms of an appropriate finance agreement with the Burlington County Bridge Commission for the purpose of financing of constructing a municipal firehouse, and such other municipal public facilities as may be determined necessary by the Township Council.
2. Said officials are authorized to engage with the Township Engineer, Architect, Bond Counsel, Financial Advisor, Auditor, and any other professionals deemed necessary, together with representatives of the Burlington County Bridge Commission, to prepare all agreements, financing documents, resolutions, ordinances, and related materials necessary to implement the Project.

3. The Chief Financial Officer is authorized to coordinate with Bond Counsel, the Township's Financial Advisor, and representatives of the Burlington County Bridge Commission regarding the financing of the Township's share of the Project, including the preparation of financial analyses, repayment schedules, lease agreements, installment purchase agreements, or other financing documents as may be appropriate.
4. The Township Solicitor is authorized to review, revise, negotiate, and approve as to legal form all agreements and documents related to financing project.
5. The Township Manager is authorized to execute preliminary agreements, letters of intent, memoranda of understanding, and other documents necessary to advance the Project, provided that any financing agreement or other binding financial obligation shall be subject to subsequent approval by the Township Council where required by law.
6. Nothing contained herein shall obligate the Township to incur any financial obligation until such time as the Township Council approves the final financing documents and authorizes the Project by the appropriate ordinance(s) and/or resolution(s) in accordance with applicable law.
7. This Resolution shall take effect immediately upon adoption.

WHEREAS, such resolution of certification shall be adopted by the governing body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the governing body to the penalty provisions of R.S. 52:27BB-52 - to wit:

R.S. 52:27BB-52 – "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office."

NOW, THEREFORE BE IT RESOLVED, that the Township Council of the Township of Maple Shade, hereby states that it has complied with N.J.A.C. 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.
